



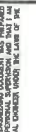
VICINITY MAP

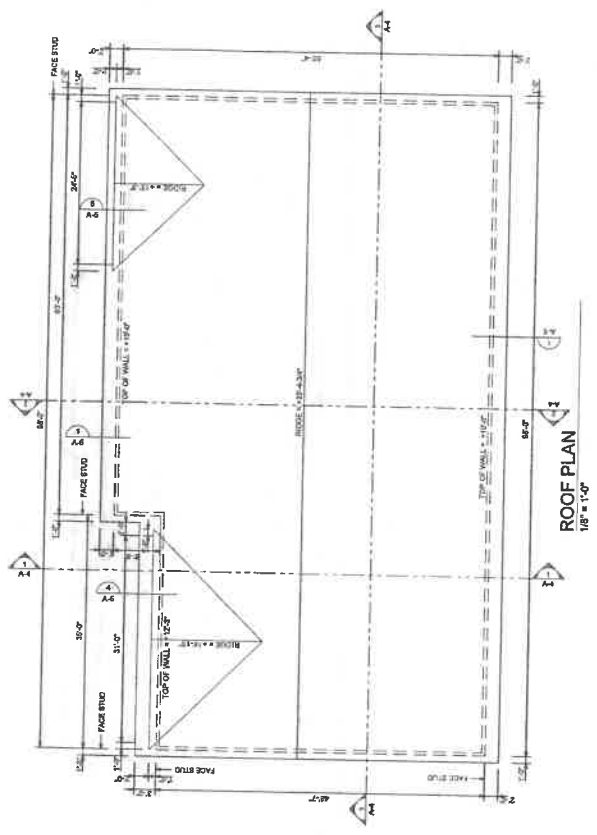
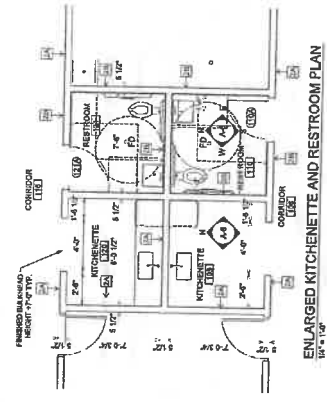
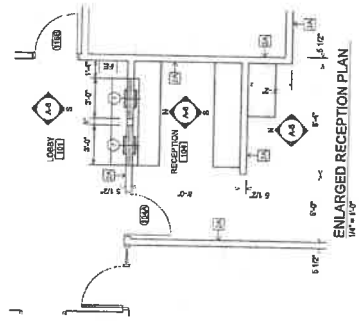
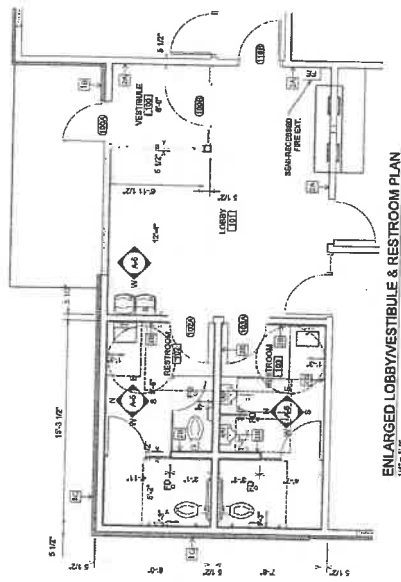
