## December 12, 2022

The December 12, 2022, meeting of the Monroe City Council was called to order by Mayor Douglas Duinink at 7:00 p.m. at the Monroe City Hall. Roll call was taken. Council members in attendance were: Jennifer St. Peter, Stacie McCoy, Sean Wilson, Jean Goemaat and Andrea Steenhoek. City employees in attendance were: Public Works Director- Marc Van Wyk and City Clerk/Administrator-Kim Thomas.

Visitors at the meeting were: Jamee Pierson and Daryl Phifer.

Council Member Jean Goemaat moved and was seconded by Council Member Stacie McCoy to approve the consent agenda. Items included the bills and minutes from the November meeting and the Clerk and Treasurer Report from November. Motion carried 5-0.

Director Marc Van Wyk reported on the water main break that happened December 11<sup>th</sup> on North Fillmore Street. All repairs were completed within a couple hours. Mayor Duinink reported that he had received a phone call concerning the break Sunday evening. Neighbors in that area are concerned about the brown water they have on that side of town. Mayor Duinink also reminded Van Wyk that the tree trunk on his brother's property still needs removed. Council Member Wilson reported that the new attack truck is at the fire station. "Equipment still needs to be installed on the new attack truck," stated Wilson.

Council Member St. Peter moved and was seconded by Council Member Steenhoek to open the 7:05 p.m. public hearing on the proposal to sell real property located along 407 N. Buchanan Street. Motion carried 5-0. Thomas reported there were no written or oral objections to the sale. St. Peter moved and was seconded by Steenhoek to close the hearing at 7:06 p.m. Motion carried 5-0.

Steenhoek moved and was seconded by St. Peter to approve <u>RESOLUTION NO. 41-2022</u>. A resolution approving the sale of part of North Buchanan Street, City of Monroe, Jasper County, Iowa. Upon roll call vote, motion carried unanimously 5-0.

- St. Peter moved and was seconded by Goemaat to approve <u>RESOLUTION NO. 42-2022</u>. A resolution approving the transfer of funds within the City of Monroe. Upon roll call vote, motion carried unanimously 5-0.
- St. Peter moved and was seconded by Goemaat to approve the first reading of AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF MONROE, IOWA, BY ADDING SUBSECTION 47.09 TO CHAPTER 47 OF THE MONROE CODE OF ORDINANCES. This amendment will allow dogs on the Monroe Recreation Walking Trail and Disc Golf Course. Upon roll call vote, motion carried 5-0.

Steenhoek moved and was seconded by St. Peter to approve <u>RESOLUTION NO. 43-2022</u>. A resolution assigning the address of 702 N. Main Street in the City of Monroe, Iowa. Motion carried 5-0.

The council discussed request for proposals for the acquisition and development of real estate owned by the city. The city currently has 2 properties, a commercial property at 108 W. Sherman Street and a residential lot at 702 N. Main Street. The council agreed to set minimum bids on both properties with an assessment value of \$75,000 after 18 months at both locations. The council agreed to accept request for proposals of both properties at the January meeting.

The council agreed to set two budget workshop meetings in January. The first meeting will be on January 9<sup>th</sup> at 5:45 p.m. and the second on January 23<sup>rd</sup> at 6:00 p.m.

The employment agreement between the City of Monroe and Kimberly Thomas was reviewed. Goemaat moved and was seconded by St. Peter to renew the existing contract for another 2-year period. Upon roll call vote, motion carried unanimously 5-0.

Open forum: Mayor Duinink mentioned the United Methodist Church is having a drive through coffee and cookie pick up on Monday mornings from 6:00 a.m. to 8:00 a.m. Wilson reminded everyone that Santa Claus will be at Jersey Freeze on December 17<sup>th</sup> starting at noon. "Duane Phifer was recently laid to rest after servicing 55 years on the Monroe Fire Department," stated Wilson.
